If the relevant products are not removed, or in the event of a breach of sections 1, 2, 3, 5 and 6 of the Exhibition Regulations, which are identified during the Slow Food trade fair by Messe Stuttgart or Slow Food Germany, a contractual penalty of € 200.00 / product is charged. Furthermore, in the case of a recurrence the stand is closed and the exhibitor is excluded from participation in future trade fairs.
