Work outside these time windows is subject to a charge and permitted only after prior notification of and approval by the Technical Event Service.

Due to reasons of safety, the presence of all persons who are not directly involved in compulsorily insurable work, especially minors, shall be prohibited during stand set-up and dismantling work in the halls and in the outdoor exhibition area!

Smoking inside the exhibition halls is prohibited at all times!

Access to the trade fair grounds for **Set-up** (9 – 12 April) and **Dismantling** (15 – 17 April) via:

- Tor 1 (Gate 1) for exhibitors in halls 1 and 2 / South (gate 2.1)
- Tor 4 (Gate 4) for exhibitors halls 4 and 2 / North (gate 2.2)

Exit for Set-up and Dismantling only via Gate 5.

During the fair (13 – 15 April) access and exit for exhibitors only via Gate 4.

Parking areas for loading and unloading: P4, P5, P6

The period that vehicles may be present on the trade fairgrounds is in principle restricted.

	Set-up and dismantling	
Cars:	2 hours	
Cars with trailer / (small) vans:	2 hours	
Trucks:	3 hours	

An access deposit of **€ 100 in cash** applies on all stand set-up and exhibition days.

The **cash** deposit has to be paid before entering the fair grounds (Gates 1 or 4). It is returned upon exit from the fair grounds within the time limits at Gate 5. Please see access regulations above.

You will forfeit the deposit if you do not leave on time.

If you need more time please contact the security staff at Gates 1 or 4.

We trust you understand that time limits cannot always be extended due to the traffic situation.

On the last trade fair day there is no access for vehicles to the trade fairgrounds from 12.00 noon until after the end of the event.
