1. Organizer

Organizer of the exhibition is the company named in the „Special Terms and Conditions of Participation“.

2. Implementation and Management

Landesmesse Stuttgart GmbH, Messe Stuttgart International (LMS) will be acting on its own account within the context of these "General Terms and Conditions of Participation" and the "Special Terms and Conditions of Participation". LMS plans and implements the participation of these exhibitors, which announced themselves over LMS.

3. Eligibility of Registration

Authorized to apply for participation are companies who display goods according to the nomenclature of the exhibition.

4. Registration, Admission and Stand Confirmation

- 4.01 Registration for participation is constituted by receipt by LMS of the applicant's registration form, duly completed and bearing a legally binding signature in compliance with these Standard Terms and Conditions of Participation. Registration shall be regarded as binding irrespective of admission. Any conditions or reservations made on registration are inadmissible and shall be considered inapplicable.
- 4.02 The closing date for registrations can be found in the attached "Special Terms and Conditions of Participation".
- 4.03 LMS shall send written confirmation of receipt of registration. However, neither registration nor confirmation of receipt shall constitute any claim to admission or specific size and/or location of booth. In particular, by arrangement with the organizers of the participation LMS is entitled to reduce the registered square meterage in the event of oversubscription of available exhibition space.
- 4.04 The registering party shall be admitted -according to available exhibition space and-provided it has met the prerequisites specified in these "General Terms and Conditions of Participation" and "Special Terms and Conditions of Participation" and-provided that its exhibit(s) correspond(s) to the general framework and conception of the exhibition.
- 4.05 Companies failing to meet their financial commitments from earlier events may be excluded from admission.
- 4.06 The dispatch of admission shall constitute the conclusion of contract between LMS and the exhibitor. The following certificate of stand confirmation shall be accompanied by a ground plan showing the location and dimensions of the booth. LMS cannot be held liable for any discrepancies in measurement nor any resulting minor differences between the projected and actual size of booth.
- 4.07 Subsequent to admission of the exhibitor, it may happen that the latter is allocated exhibition space by LMS other than specified in the stand confirmation certificate if - this is necessary in the interest of preserving the overall image should the exhibition space offered by LMS not be let in its entirety, and - the exhibitor is provided with exhibition space essentially equivalent to the original space allocated in terms of location and size. Should LMS be forced by circumstances beyond its control, such as public authority directives or instructions from the organizer to relocate or modify individual booths and/or entrances, accessways and exits, this shall not constitute grounds for assertion of claims.
- 4.08 Following admission of the exhibitor by LMS, both registration and the obligation to pay the participation fee shall remain legally binding, even in cases where, for example, the competent authorities wholly or partially fail to comply with the exhibitor's import requirements, the exhibit(s) do(es) not arrive in the time for the event or at all (e.g. due to loss, transportation or customs delay) or in the event of failure to procure entry visas for the exhibitor or his authorized representatives in time.
- 4.09 Booths which have not been claimed by the exhibitor or his authorized representative one day prior to commencement of the event may be otherwise disposed of without the exhibitor having any grounds for assertion of claims over and above the rights specified in item 8.
- 4.10 LMS is authorized to revoke admission if the latter was granted on the basis of false prerequisites or statements or such admission criteria subsequently lapse.

5. Sub-Exhibitors

- 5.01 As a matter of principle, exhibition booths are only rented as complete units solely to one contractual partner. Only with the prior written consent of LMS is the contractual partner entitled to incorporate into his booth any sub-exhibitor companies which he is obliged to name beforehand. LMS shall only grant its consent once the sub-exhibitor companies in question have submitted written acknowledgement of the "General Terms and Conditions of Participation". The sub-exhibitor is subject to the same conditions as the main exhibitor.
- 5.02 The main exhibitor shall be liable for any fault on the part of his sub-exhibitors including persons employed in the performance of their obligations in the same way as for his own fault and for any fault on the part of persons employed in the performance of his obligations. The same shall apply to vicarious agents. Both main exhibitor and sub-exhibitor shall be liable to LMS as joint and several debtors.

6. Terms of Payment

- 6.01 A deposit the amount of which is stipulated in the "Special Terms and Conditions of Participation" is due five months before the event starts. The deposit will be refunded in the case of non-admission.
- 6.02 Following receipt of invoice for the participation fee(s) the total amount less paid deposit shall become due for payment two months before the beginning of the event as stipulated in the "Special Terms and Conditions of Participation".
- 6.03 In the event of failure to comply with the payment deadline despite reminder and granting of a period of grace, LMS is entitled to rescind the contract and otherwise dispose of the exhibition space. Should the exhibition space have been successfully rented to a third party, - before admission the registration fee shall be forfeited, not exceeding € 250,00 - after admission the exhibitor shall pay 25 % of the participation fee. Should LMS be unable to otherwise dispose of the exhibition space, the exhibitor shall be liable to pay the entire participation fee. The exhibitor is granted the right to prove to the executive company that the latter has incurred no loss or only a substantially reduced loss.

7. Assignment, Setoff, Right of Retention

The assignment of claims against LMS is herewith precluded. Setoff and rights of retention are similarly precluded save for the existence of any uncontested or final and conclusive claim against LMS.

8. Rescission

- 8.01 LMS is entitled to rescind the contract should application be made for institution of composition or bankruptcy proceedings in respect of the exhibitor's property. In any such case, the exhibitor undertakes to notify LMS immediately.
- 8.02 A rescission is only possible before deadline of application.
- 8.03 Should the registering party rescind the contract subsequent to the closing date for registration but prior to admission, the deposit paid shall be forfeited up to a maximum of € 250,-.
- 8.04 Subsequent to admission the exhibitor is no longer entitled to rescind the contract or reduce the exhibition space. Should the exhibitor nevertheless decline to occupy the exhibition space allocated to him, he must- pay the entire participation fee unless the space can be other-wise rented by LMS- pay 25 % of the participation fee, provided that the space can be otherwise rented by LMS. The allocation to another exhibitor for aesthetic reasons of the space not used by the exhibitor withdrawing from the agreement is not regarded as a new rental if the trade fair management receives no further income from the space previously allotted to the replaced exhibitor. As long as unoccupied exhibition space is available, no new rental exists.

- 8.05 Rescission by the exhibitor (item 8.02) and/or waiver of exhibition space allocated (item 8.03) shall only become effective on receipt of the exhibitor's written declaration by LMS.

9. Booth Equipment, Design and Markings

The equipping and individual design of booths over and above the services provided by LMS as specified in the "Special Terms and Conditions of Participation" shall be the concern of each exhibitor. However, the type of booth design shall be governed by the building regulations valid at the event location and the building guidelines of LMS. The exhibitor undertakes to agree all design-related measures with LMS beforehand. Any booth design failing to comply with the building regulations valid at the event location or the building guidelines of LMS may be re-moved or altered by LMS at the exhibitor's expense.

10. Exhibits, Direct Selling and Booth Personnel

Only goods according to the nomenclature of the specific fair can be displayed. Exhibition of inflammable and pungent products or those whose demonstration involves noise requires the prior consent of LMS. Direct selling (individual sales to visitors) is not permitted as a matter of principle. Exhibitors undertake to ensure the presence of specialist stand personnel throughout the entire duration of the event.

11. Transportation, Assembly and Dismantling of Exhibits and Booth Equipment

- 11.01 Transportation of exhibits to and from the exhibition booth, storage of empty containers, use of lifting and conveying gear, deployment of personnel for packing and unpacking, assembly and dismantling of exhibits, repacking and any other activities connected with the above shall be the sole concern of the exhibitor. LMS cannot in any way be held liable for the above. The organizers are entitled to prescribe with binding force a local forwarding agent to handle all transportation within the exhibition, even subsequent to stipulation of the "Special Terms and Conditions of Participation".
- 11.02 Stand construction, decoration and moving in of the exhibits have to be finished before 19.00 hrs on the day prior to the opening of the exhibition.
- 11.03 The days and times for stand construction and dismantling are specified in the "Special Terms and Conditions of Participation". Exhibits, goods and belongings of the exhibitor may be removed from the exhibition area without further notice by the organizer after the official ending of the dismantling period. In that case cost incurred and the risk of loss or damage shall lie with the exhibitor.

12. Insurance and Third-Party Liability

- 12.01 Insurance of exhibits against all transportation risks and during the event itself, notably against damage, theft etc., shall be the sole concern of the exhibitor.
- 12.02 The exhibitor is liable for all damage caused to third parties by his participation in the exhibition, including damage to buildings within the exhibition complex and to any of its facilities.
- 12.03 The organizer and LMS accept no liability for damage to property or personal injury save where they, their legal representatives or persons employed in the performance of their obligations can be proven to have acted with intent or gross negligence. Here, the onus of proof lies with the exhibitor.
- 12.04 The organizer and LMS can on no account be held liable for any damage to or theft of exhibits, not even where in isolated cases display work was carried out by LMS itself. In addition, by way of acknowledging the aforesaid condition of participation, the exhibitor expressly releases the organizer and LMS from any third-party rights of recourse.

13. Reservation clause

- 13.01 1Any provisions and/or guidelines of the competent authorities and the host country which deviate from these Terms and Conditions of Participation or give rise to additional restrictions shall take priority at all times. The organizer and LMS cannot be held liable for any damage or other disadvantages incurred by the exhibitor as a result.
- 13.02 The organizers are entitled to postpone, shorten, extend, suspend or temporarily, conclusively, partially or wholly close the participation should unforeseen circumstances such as force majeure, natural disasters, war, unrest, strikes, breakdown or impairment of transport and/or communications networks require any such measures. In the case of postponement, shortening, extension or closure of the event, the exhibitor shall have no claim to compensation of any damage he experiences as a result. If the exhibitor is no longer interested in participating in the event because of any such measure and therefore decides to waive occupation of the exhibition space allocated to him, he is entitled to rescind the contract. Rescission must be declared in writing immediately after case, the exhibitor's obligations are governed by item 8.02 above. In the case of cancellation of the event itself neither the organizer nor LMS may be held liable for any damage or other disadvantages which the exhibitor experiences as a result. Should LMS or the organizer so request, the exhibitor shall undertake to cover a reasonable share of the cost incurring in preparing the event. The amount of the quota to be paid by each exhibitor shall be determined by LMS on the basis of a hearing of the economic organizations involved.

14. Final Provisions

- 14.01 With regard to the scope of performance covered by the participation fee, reference is made to the "Special Terms and Conditions of Participation".
- 14.02 Should the exhibitor have commissioned LMS to perform services chargeable over and above the scope of the "Special Terms and Conditions of Participation", he shall be invoiced the respective costs incurred.
- 14.03 The reciprocal rights and obligations under this contractual relationship are subject to the law of the Federal Republic of Germany.
- 14.04 The place of jurisdiction and the place of performance for payment obligations shall be the domicile of LMS, Stuttgart.
- 14.05 The contract and any amendments thereto must be made in writing. Should any of the above provisions be null and void, this shall not affect the remaining provisions. The latter should be interpreted in such a way that the aim and purpose of the contract is upheld.
- 14.06 All claims of the part of the exhibitor against LMS shall become statute-barred within 6 months. The period of statutory limitation shall commence at the end of the month in which the final day of the event falls.
