For safety reasons, the presence of all persons who are not directly involved in compulsorily insurable work, especially minors, shall be prohibited during stand set-up and dismantling work in the halls and in the outdoor exhibition area!

Smoking inside the exhibition halls is prohibited at all times!

Access to the trade fair site is granted daily according to the stand set-up and dismantling timetable. For details please see the page "Access regulations". It is generally not allowed to drive into the halls.

Parking

Digitalisation of entry and exit management with VisiFair

VisiFair, the new digital entry and exit management system of Messe Stuttgart, will be used during the events at the Stuttgart location. The previous entry regulations with a deposit no longer apply.

Access to the trade fair center for set-up and dismatling is only possible after booking a time slot at a fee! After leaving the loading bay, free parking is available on the grounds for intermediate paking (til 20.00).

Information on booking your time slot

- In order to be able to use the VisiFair booking system, please perform a one-off initial registration.
 You can then log on.

Due to the limited number of time slots, we recommend an early booking ahead of the event.

- » Entry to the trade fair grounds is via Gate 2 of the truck pool. Follow the "Anlieferung" (Delivery) signs at the entrance to the trade fair grounds.
- » On the last day of the trade fair, access to the premises is not possible after 12.00 a.m. until the halls are officially declared open after the end of the trade fair.
